- CREDIT TERMS -

The customer requests that Big "D" Bolt & Tool Company, Inc. or any assumed name or fictitious name or trade name under which it trades or does business, hereinafter known as Big "D", sell goods on account in consideration of which the customer and Big "D" agree as follows:

The customer agrees to pay for all goods purchased on or before the date that is stated on the invoice.

The customer agrees to pay a service charge on the outstanding balance for which payment has not been received according to the terms stated. The service charge shall be 1-1/2% per month of the customer's outstanding balance and such service charges shall become part of the customer's outstanding balance.

In the event Big "D" must take legal action to collect this account, the customer agrees to pay all reasonable attorney's fees, court costs, sheriff's fees, bond costs and lien costs incurred by Big "D".

If the customer is not a corporation, the principal owners will remain personally liable for any indebtedness incurred on the aforesaid account even if they later incorporate, unless the customer serves written notice of said incorporation by certified-mail, return receipt requested, upon Big "D" at the above indicated address. Personal liability shall continue for the account balance before said notice is received.

The customer warrants that it will use all goods purchased under this account for business purposes and that the customer is not a consumer as defined by any applicable federal or state usury law.

The customer hereby waves any right to claim consequential damages for any reason, in the event any material is defective. Big "D" will replace said defective material and this will be the sole remedy of the customer.

If any provisions of this agreement shall be invalid or unenforceable, the remainder of the provisions of this agreement shall not be affected and each and every provision shall be enforceable to the fullest extent permitted by the law.

The undersigned does hereby agree to the terms of credit, service charges, and further hereby guarantees all indebtedness. The undersigned hereby signs this agreement and binds the foregoing business to the terms in the credit application and as to the terms of the guaranty above. The undersigned does hereby state that the information in this application is true and correct and can be relied upon by Big "D" and that the undersigned has the authority to sign this application. The undersigned authorizes the indicated companies to verify said information upon request.
